
Product Environmental Profile

Lexium Integrated Drive ILE with Gearbox







Product overview

The main purpose of the Lexium Integrated Drive ILE with gearbox is to control the variation of the rotational speed and position of a DC brushless electric motor.

The functional unit is to: ``coordinate and synchronize motion control 70% of the time for 10 years''.

This range consists of Integrated Drives ILE with brushless DC motors with ratings from 3.8A to 5A for operation on 24V to 36V, DC-Supply with gearboxes.


The representative product used for the analysis is ILE1F662S2019 - Lexium ILE DC brushless motor – 24VDC to 36VDC – CANopen DS301 – 5A with gearbox PLE 60 -020.

The environmental impacts of this referenced product are representative of the impacts of the other products of the range which are developed with a similar technology.

The environmental analysis was performed in conformity with ISO 14040.

Constituent materials

The mass of the product range is from 1,80 kg and 7,35 kg including packaging. It is 3,48 kg for the ILE1F662S2019. The constituent materials are distributed as follows:



Substance assessment

Products of this range are designed in conformity with the requirements of the European RoHS Directive 2011/65/EU and do not contain, or only contain in the authorised proportions, lead, mercury, cadmium, hexavalent chromium or flame retardants (polybrominated biphenyls - PBB, polybrominated diphenyl ethers - PBDE) as mentioned in the Directive

Manufacturing

The Lexium Integrated Drive ILE with gearbox product range is manufactured at a Schneider Electric production site on which an ISO14001 certified environmental management system has been established.

Distribution

The weight and volume of the packaging have been optimized, based on the European Union's packaging directive.

The ILE1F662S2019 packaging weight is 492 g. It consists of cardboard (434 g), polyethylene film (47 g) and paper (11 g).

Use

The products of the Lexium Integrated Drive ILE with gearbox range do not generate environmental pollution (noise, emissions) requiring special precautionary measures in standard use.

The electrical power consumption depends on the conditions under which the product is implemented and used. The electrical power consumed by the Lexium Integrated Drive ILE with gearbox range is between 15 W and 35 W. It is 25 W in active mode 20% of the time and 3 W in standby mode 50% of the time for the referenced ILE1F662S2019.

End of life

At end of life, the products in the Lexium Integrated Drive ILE with gearbox have been optimized to decrease the amount of waste and allow recovery of the product components and materials.

This product range contains electronic cards that should be separated from the stream of waste so as to optimize end-of-life treatment by special treatments. The location of these components and other recommendations are given in the End of Life Instruction document which is available for this product range on the Schneider-Electric Green Premium website

The recyclability potential of the products has been evaluated using the "ECO DEEE recyclability and recoverability calculation method" (version V1, 20 Sep. 2008 presented to the French Agency for Environment and Energy Management: ADEME).

According to this method, the potential recyclability ratio without packaging is: 77%.

As described in the recyclability calculation method this ratio includes only metals and plastics which have proven industrial recycling processes.

Environmental impacts

Life cycle assessment has been performed on the following life cycle phases: Materials and Manufacturing (M), Distribution (D), Installation (I) Use (U), and End of life (E).

Modeling hypothesis and method:

- The calculation was performed on ILE1F662S2019.
- Product packaging is included.
- Installation components: no special components included.
- Scenario for the Use phase: this product range is included in the category 2 "Energy consuming product" assumed service life is 10 years and use scenario is:
 - Active phase: consumed power 25 W during 20 % uptime
 - Standby phase: consumed power 3 W during 50 % uptime
 - Off phase: consumed power 0 W during 30 % uptime
- The geographical representative area for the assessment is European and the electrical power model used for calculation is the European model.
- End of life impacts are based on a worst case transport distance to the recycling plant (1000km)

Life cycle assessment has been performed with the EIME software (Environmental Impact and Management Explorer), version 5 and with its database version 2013-02

The Use phase is the life cycle phase which has the greatest impact on the majority of environmental indicators.

The environmental impacts of other products in this family may be estimated as follow: Raw Material Depletion and Hazardous Wastes production are proportional to the weight of the product. Water Eutrophication is half proportional to the weight and half proportional to the energy consumption of the product. Other impact categories are proportional to the energy consumption of the product.

System approach

As the products of the range are designed in accordance with the European RoHS Directive 2011/65/EU, they can be incorporated without any restriction in an assembly or an installation subject to this Directive.

Please note that the values given above are only valid within the context specified and cannot be used directly to draw up the environmental assessment of an installation.

Glossary

Air Acidification (AA)	The acid substances present in the atmosphere are carried by rain. A high level of acidity in the rain can cause damage to forests. The contribution of acidification is calculated using the acidification potentials of the substances concerned and is expressed in mode equivalent of H^{+} .
Air Toxicity (AT)	This indicator represents the air toxicity in a human environment. It takes into account the usually accepted concentrations for several gases in the air and the quantity of gas released over the life cycle. The indication given corresponds to the air volume needed to dilute these gases down to acceptable concentrations.
Energy Depletion (ED)	This indicator gives the quantity of energy consumed, whether it is from fossil, hydroelectric, nuclear or other sources. It takes into account the energy from the material produced during combustion. It is expressed in MJ.
Global Warming (GW)	The global warming of the planet is the result of the increase in the greenhouse effect due to the sunlight reflected by the earth's surface being absorbed by certain gases known as "greenhouse-effect" gases. The effect is quantified in gram equivalent of CO_2 .
Hazardous Waste Production (HWP)	This indicator quantifies the quantity of specially treated waste created during all the life cycle phases (manufacturing, distribution and utilization). For example, special industrial waste in the manufacturing phase, waste associated with the production of electrical power, etc. It is expressed in kg.
Ozone Depletion (OD)	This indicator defines the contribution to the phenomenon of the disappearance of the stratospheric ozone layer due to the emission of certain specific gases. The effect is expressed in gram equivalent of CFC-11.
Photochemical Ozone Creation (POC)	This indicator quantifies the contribution to the "smog" phenomenon (the photochemical oxidation of certain gases which generates ozone) and is expressed in gram equivalent of ethylene (C_2H_4).
Raw Material Depletion (RMD)	This indicator quantifies the consumption of raw materials during the life cycle of the product. It is expressed as the fraction of natural resources that disappear each year, with respect to all the annual reserves of the material.
Water Depletion (WD)	This indicator calculates the volume of water consumed, including drinking water and water from industrial sources. It is expressed in dm³.
Water Eutrophication (WE)	Eutrophication is a natural process defined as the enrichment in mineral salts of marine or lake waters or a process accelerated by human intervention, defined as the enrichment in nutritive elements (phosphorous compounds, nitrogen compounds and organic matter). This indicator represents the water eutrophication of lakes and marine waters by the release of specific substances in the effluents. It is expressed in grams equivalency of PO43-(phosphate).
Water Toxicity (WT)	This indicator represents the water toxicity. It takes into account the usually accepted concentrations for several substances in water and the quantity of substances released over the life cycle. The indication given corresponds to the water volume needed to dilute these substances down to acceptable concentrations.
