TECHNICAL SCHEDULE No 14/2/88

1. Description of Pattern **approved on 29/07/15**
amended on 28/07/20

A Schneider Electric model iEM3255 class 0.5 electronic current transformer (CT) operated static watt hour meter (Figure 1) used to measure electrical energy.

1.1 Field of Operation

The field of operation of the measuring system is determined by the following characteristics:

- Number of phases 3
- Number of wires 3 or 4
- Reference frequency 50 Hz
- Reference ambient temperature ranges:
 - specified range of operation -25 to 55°C
 - limit range of operation -25 to 60°C
- Reference voltage 3×100/173 277/480 V AC
- Rated currents: Rated current, I_n 5 A
Maximum current, I_{max} 6 A
- Meter constant 5000 imp/kWh
- Accuracy class 0.5

1.2 Features/Functions

- Electronic (LCD) digital indicator
- Internal crystal clock
- One (1) × three-phase or three (3) × single phase configuration
- Measurement in positive and negative direction

2. Description of Variant 1 approved on 29/07/15

Certain other models of the iEM3200 series as listed below:

- iEM3200 basic energy meter
- iEM3210 energy meter with pulse output
- iEM3215 multi-tariff energy meter
- iEM3250 energy meter & electrical parameter plus RS485 comm port
- iEM3255 (the pattern) advanced multi-tariff energy meter & electrical parameter plus RS485 comm port.
- iEM3265 advanced multi-tariff energy meter & electrical parameter plus BACnet MS/TP comm port
- iEM3275 advanced multi-tariff energy meter & electrical parameter plus LON TP/FT-10 comm port

All of the models have the same field of operation. The differences relate to features and functions.

3. Description of Variant 2 approved on 18/08/20

The pattern, or any of the models listed under variant 1, configured for use as three single-phase meters.

TEST PROCEDURE

Instruments tested for initial verification shall comply with the certificate of approval and technical schedule, and the maximum permissible errors for verifications at the operating conditions in effect at the time of verification.

The maximum permissible errors are specified in the *National Trade Measurement Regulations 2009* (Cth).

Meters shall be verified in accordance with NITP 14 *National Instrument Test Procedures for Utility Meters*.

Evidence of verification shall be confirmed via the meter serial number and certificate of verification issued by a utility meter verifier in accordance with NITP 14.

NOTE: NMI reserves the right to vary this procedure. Any such variation shall be notified in writing by NMI.
